

Give us your views on the interim bus policy priorities

Overview

We are developing a new interim bus policy, and we would like your view on the priorities we have identified.

The feedback we receive from this will help us to shape the interim bus policy and feed into the development of a future Local Transport Plan.

Background

West Northamptonshire Council supports several local bus services, works with community transport operators to enable connectivity in rural areas, and supports the Concessionary Scheme that provides free travel for eligible residents.

A short-term local bus policy is being developed as part of a review of current provision. An interim bus policy will enable the Council to maintain support for local bus services and the communities they serve until a new Local Transport Plan is developed and adopted around late 2024, early 2025.

Further information

Buses are the most used form of public transport in England, meeting the needs of old and young, rural and urban communities, and help to support the prosperity of towns and cities. Unfortunately, many bus services have noticed a decline in customers, as well as increased running costs, particularly since the Covid pandemic.

In response to a request from the Department of Transport, we have reviewed the local bus network and how we can best support it to provide key local links. Most local bus services are operated on a commercial basis with the council having little control over them. A small number of services are contracted by the council, but the funding for this is limited. The new bus policy will guide decisions on how we spend this funding to best meet residents and visitors travel needs.

The journey is just starting in West Northamptonshire, with new government funding and staff resources becoming available, and a partnership between the council and local bus operators established to both protect and enhance existing local bus networks, as well as encouraging a step change in provision.

Because most local bus services within West Northamptonshire are operated on a commercial basis without direct financial support, a partnership is essential to bring key

stakeholders and our community together, bringing the best outcomes to bus providers and the customers they serve.
